Miles College Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA/HEERF II) STUDENT AID REPORT-FINAL for Quarter Ending December 31, 2021

Award: P425E200477 - MILES COLLEGE, INC.

On January 17, 2021, Miles College received notification from the Department of Education of funding for "Supplemental Grant Funds for Students" under Section 314(a)(a) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 ("CRRSAA"). These funds, also, are referred to as *HEERF II* (Higher Education Emergency Relief Funds) funds.

According to the legislative appropriation (Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES" also referred to as *HEERF I*) that the College received in the Spring 2020, this second allocation of funds *must* be used to provide Emergency Financial Aid Grants to Students.

Miles College received \$ 1,628,967 under the CRRSAA/HEERF II Program from a Grant Award Notification for Emergency Financial Aid Grants to Students. The total cumulative amount allocated under CARES/HEERF I and CRRSAA/HEERF II for "Emergency Financial Aid Grants to Students" is \$3,257,934.

Students received a reminder from the President's desk on September 24, 2021. The communication advised students who completed the *Emergency Financial Aid Application* at the beginning of the semester <u>and</u> checked the appropriate box that a portion of their aid could be applied to their student account. (This and other communications are posted on the website). It also advised students that the College was providing them with a second opportunity to request "account balance payment assistance" and referred them to the Office of Financial Aid. In compliance with subsequent requirements (under HEERF III), this correspondence also advised students that if their circumstances had changed, they could consult with Financial Aid for a recalculation of the "expected family contribution."

The estimated total number of students at the institution who were eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA (a) (1) program is 1501. (Most of these students received direct emergency grants as described in the HEERF III Student Aid report and posted on the College's website.)

The total number of students who received an Emergency Financial Aid Grant under the CRRSAA was 315 for a total of \$699,797. This "emergency aid grant" enabled the College to relieve students of some of their ongoing challenges by addressing their student account balances.

Miles College American Rescue Plan (ARP/HEERF III) STUDENT AID REPORT for Quarter Ending December 31, 2021

On May 20, 2021, Miles College received notification from the Department of Education of funding for "Supplemental Grant Funds for Students" under Section 203 of the American Rescue Plan (ARP) which mirrored the HEERF II awards to students. (This award, also, is referred to as HEERF III (Higher Education Emergency Relief Funds).

According to the authorization for this third funding stream (P.L. 117-2) of the American Rescue Plan, the College received additional funds that *must* be used to provide "Emergency Financial Aid Grants to Students;" the condition being that all currently enrolled students are eligible to receive assistance.

Miles College received \$4,678,050 under the ARP/HEERF III Program from a Grant Award Notification for Emergency Financial Aid Grants to Students. The total cumulative amount allocated under CARES/HEERF I, CRRSAA/HEERF II, and the ARP/HEERF III for "Emergency Financial Aid Grants to Students" is \$7,935,984; \$3,257,934 of which was expended from HEERF II/Student Aid and which is reported in the final report for HEERF II Student Aid for the quarter ending December 31, 2021.

Students received guidance from the President's desk on September 24, 2021. This communication advised students that the College would continue to receive emergency financial aid applications online as long as funds were available. (A copy of this correspondence and a FAQ guide for students about ARP funding is posted on the College's website). As required under the HEERF III guidelines, this correspondence advised students that if their circumstances had changed, they could consult with Financial Aid for a re-calculation of the "expected family contribution."

The total number of currently enrolled students who are eligible to receive Emergency Financial Aid Grants to Students under the ARP/HEERF III program is 1501; 297 of whom received assistance with outstanding account balance in the amount of \$676,227. 103 students applied for direct help; because of challenges they were facing outside of school was \$63,598. The total amount of funds distributed for direct grants to students and assisting with clear account balances were during this reporting period is \$739,825.
