The most successful strategy to date is to continue to place emphasis on the constructs of the conceptual framework -- "The Teacher: A Facilitator of Learning" to ensure that candidates realize the importance of creating a climate for learning, initiating meaningful activities, providing encouragement and acquiring knowledge. This strategy requires a specific focus on diversity, the exceptional child, working in urban, suburban and rural school settings, enhanced classrooms, and educating all children. Also, by completing interviews during their junior year, students' oral and written communication skills are evaluated. Additionally, selecting highly capable faculty, providing focused and intentional professional development and enhancing college/school partnerships have been the most successful strategies in assuring compliance.

Miles College requires candidate to take ED 300 (Technology for Teachers) which is a course designed to introduce the candidates to skills associated with integrating technology into the teaching and learning process. Candidates are exposed to software application including word processing, spreadsheets, databases, multimedia presentations, and web sites related to various content areas. Candidates are also required to complete an assessment of their field experience in Tk20. Tk20 is the assessment system used in the Miles College Division of Education. Candidates are also expected to use email and Internet applications throughout this course.

Students are required to begin gathering information that will be used in their e-portfolio in courses such ED 306 (Principles of Teaching) and ED 448(Classroom Management). These courses require students to expand the use of technology by creating and displaying different documents such as Field Experience Documentation, Observation Reports. Conferences /Training, Webinars and other activities are also component of the e-portfolio.
